



Rainwood Stallion 2011 Stallion Contract



This agreement is by and between **Teresa Rippey**, owner of the stallion **Kings Diamond Jet APHA # 902,200** hereinafter referred to as Stallion Owner and _____, hereinafter referred to as mare owner. Stallion owner hereby agrees to breed the mare _____. Registration number _____, Which is owned or leased by said mare owner during the breeding season of 2011.

Mare owner agrees to pay the following fees for service(s) pursuant to this agreement.

1. Any boarding charges as per agreement with **Misc. Acres Stallion Station**

2. A veterinarian's certificate of health must accompany mare at time of arrival of mare, including proof of negative culture and or health check before breeding commences, At mare owner's expense. All expenses are non refundable.
3. Shoes must be pulled prior to breeding.
4. A non refundable booking fee of \$150 is due and payable upon signing of this contract. Booking fee is non-refundable. And part of the stud fee.
5. A stud fee of _____ shall be charged for service. This fee is due and payable before aforementioned mare's departure. Or \$_____ must be paid before departure, \$_____ per month must be paid until stud fee is paid in full. Breeding certificate will not be signed until stud fee is paid in full. (Some breeding certificates must have foal information filled out in conjunction with the breeding information. These certificates will be signed after the foal is born.
6. If the aforementioned mare fails to have a live foal that stands and nurses, or has twins, the mare may be returned to the service of the stallion without charge of additional stud fees, provided a licensed Veterinarian attests to such an occurrence in writing to the stallion owner within 48 hours of said occurrence.

Mare Owner agrees that the Stallion Owner reserves the right to refuse service to any mare which appears to be diseased or which is unfit for breeding or is too vicious or untrained to breed, in the opinion of the Stallion owner.

It is agreed by the parties hereto that if the aforementioned stallion should die, be sold, or become unfit for breeding before servicing aforementioned mare, or if aforementioned mare should die, be sold or become unfit for breeding before being serviced, this agreement shall be null and void, except for provisions in paragraphs 1 & 2

Mare owner hereby agrees to hold stallion owner & Misc. Acres harmless from any claim from accidental injury or death of aforementioned mare (and foal)

Should aforementioned mare (and foal) become missing, lost, strayed, seriously injured, sick, or dead Stallion owner agrees to notify Mare owner or their authorized agent immediately by telephone and subsequently by mail. .

Stallion Owner agrees to hold Mare owner harmless from any claim resulting from damage or injury by aforementioned mare and (foal).

Stallion Owner hereby agrees to maintain aforementioned mare (and foal) in good condition pursuant to this agreement, with proper care, handling, and protection, according to the rules of good animal husbandry and reasonable standards and practices of the horse industry.

If arrangements are not made to pick up mare (and foal) and all incurred expenses paid by _____
The aforementioned mare and (foal) will be considered abandoned and will be sold at public auction.

This agreement and all covenants and agreements herein contained shall accrue to and be binding upon parties hereto, their heirs, successor's administrators, and executors. Upon material breach of this agreement by one party, the other party may terminate same.

No modification of this agreement shall be binding unless in writing and executed by the parties here to.
